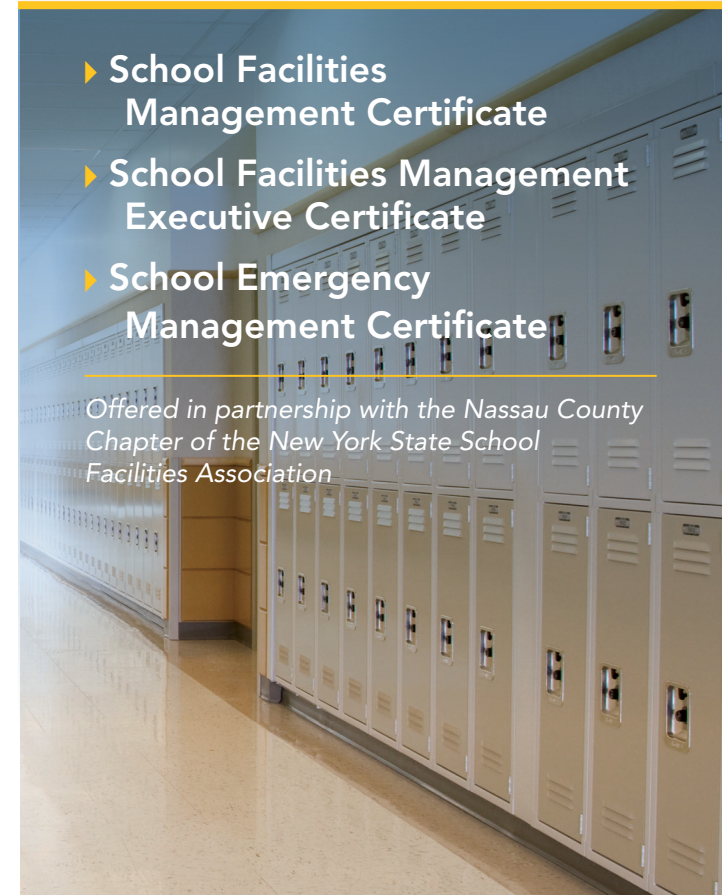

## School Facilities Management Certificate

This program is geared toward members of the school staff aspiring to careers in school facilities management or those pursuing a greater understanding of school facilities. \*This two-year certificate program, consisting of two classes per semester for a total of eight courses, focuses on the budgetary challenges and the complex rules and regulations faced by school district leaders. Led by school and industry leaders, the program is sure to add value to the services participants provide to school districts. School district leaders contribute their vast cumulative experience, knowledge, and expertise to this program with planned contributions from superintendents, business officials, Board of Education members, industry leaders, and legal experts.

The School Facilities Management Certificate Program requires successful completion of a prerequisite course plus eight (8) required courses.

## School Facilities Management Executive Certificate

The School Facilities Management Executive Certificate is being offered by Hofstra University Continuing Education in conjunction with the Nassau County Superintendents of School Buildings and Grounds Association. This certificate program provides additional leadership training to the seasoned director (five years or more) or those who have earned a School Facilities Management Certificate from Hofstra Continuing Education.

The School Facilities Management Executive Certificate Program requires successful completion of six (6) courses.

*Prerequisite: Completion of the Hofstra University School Facilities Management Certificate Program or five years' experience as a director of facilities.*
