In 2002 Hofstra University established an unprecedented fellowship program for students engaged in advocacy on behalf of the lesbian, gay, bisexual and transgendered (LGBT) community. The program demonstrates Hofstra's commitment to equality and support for LGBT individuals.

### Hofstra Law School Fellowship

The Law School's participation in the Hofstra University LGBT fellowship program includes the Fellowship for Advocacy for the Equality of Lesbian, Gay, Bisexual and Transgendered People. Each year, the Law School awards fellowships to as many as three (3) incoming J.D. students with a history of advocacy on behalf of the LGBT community.

Fellowships are awarded to students who have demonstrated a commitment to advocacy on behalf of the LGBT community. The fellowship is open to persons of all sexual orientations in recognition of the diversity of individuals who may ally themselves with sexual equality, and underscores the importance of alliances between the LGBT community and the community at large.

### Fellowship Program Overview

- A tuition fellowship of up to \$20,000 for each year of law school.
- Up to two \$5,000 summer stipends to cover living expenses during summer externships related to LGBT advocacy.
- A comprehensive course of study devoted to equality, including courses in Sexuality and the Law, Sex Discrimination and Jurisprudence, and an independent study and tutorial designed to address issues of particular concern to the LGBT community.
- Experience in legal advocacy for the LGBT community through the Law School's externship program, which places students with nonprofit organizations, including those devoted to legal advocacy on behalf of the LGBT community.
- Participation in a mentoring program with LeGal, the Lesbian and Gay Lawyers Association of Greater New York, representing one of the most diverse legal practice communities in the United States inclusive of LGBT individuals.

### Application Process

Fellowship recipients are selected on the basis of demonstrated academic ability and experience with advocacy on behalf of the LGBT community prior to law school, which may include political activity, aid to LGBT social support networks, participation in events that promote the visibility of LGBT people, and other forms of charitable or philanthropic activity. Consideration will also be given to an applicant's plans for advocacy on behalf of the LGBT community that make use of a law degree.

Applications received by Friday, February 24, 2006 will be given first consideration. Applications submitted after February 24 are encouraged and will be considered throughout the enrollment process. Application materials should be sent to:

## The need for law-trained advocates for the LGBT community is substantial:

- Discrimination in employment and housing on the basis of sexuality is legal in 36 states and on the basis of gender identity in 47 states.
- The federal government provides no civil rights protections for LGBT people in employment and housing.
- National initiatives are underway to amend the U.S. Constitution to permanently legalize discrimination against sexual minorities, particularly in relationships.
- Currently, only three states have made substantial commitments to provide benefits to lesbian and gay couples that are provided to heterosexual couples.
- According to law enforcement experts, lesbians, bisexuals, gay men and transgendered people per capita suffer more hate crimes than any other demographic group, including people of color and religious minorities.
- The federal government prohibits military service for people who are openly lesbian, gay or bisexual, or who have a propensity for same-sex sexual activity, and has discharged tens of thousands of lesbians, gay men and bisexuals from service in the last two decades.
- LGBT individuals are routinely denied custody and adoption rights.
