African Americans on Long Island Collection, 1764-. 0.8 c.f.

The collection contains documents related to the history of African-American free men and women and slaves on Long Island in the 18<sup>th</sup> and 19<sup>th</sup> centuries. Included are court documents (including certificates of acquittal, certificates of conviction, petitions, and warrants); examinations and adjudgments from pauper hearings; servant and slave indentures (bills of sale); manumissions (formal emancipations from slavery); minutes of court proceedings, many of which concern manumissions; slave receipts; correspondence; and a poster.

Arrangement: alphabetically by format and then chronologically.

(1 item) Minutes of Queens County court proceedings (court at North Hempstead), 1799. Includes minutes concerning the manumitting of three slaves, and an assault case. (1 item) Minutes of Queens County Court of General Sessions proceedings (court at North Hempstead), 1800. Includes minutes concerning the manumitting of two slaves and the discharge of a slave. (1 item)

Minutes of Queens County Circuit Court proceedings (court at North Hempstead), 1802. Includes minutes concerning assault cases involving slaves. (1 item) Minutes of Queens County Court of Common Pleas, 1804. Includes minutes concerning the manumitting of a slave. (1 item)

Minutes of Queens County Court of General Sessions proceedings (court at North Hempstead), 1808. Includes minutes concerning the manumitting of a slave. (1 item)

*New York Times*, *The*, January 17, 1861. Includes one article concerning the slave trade and another regarding the report of the Senate Select Committee on Federal Relations (New York State Legislature). Resolutions made by the committee concerned the right to secede and slavery.
