 - A. Recognizing Womens' Club Softball
 - i. Summary:
 - Hofstra womens' club softball is an already-running team that wishes to gain recognition through Student Government Association to assist with the increased demand that they have seen for their team. As the team continues to expand, the club hopes to be supported via SGA.

- 2. Womens' softball sees this opportunity to not only assist with their current members, but to promote the attention of new members as well.
- ii. Questions for Hofstra Women's Club Softball
 - 1. "How are the arrangements for the club so far?"
 - a. Answer: A coach has been selected and is current going through the process to be cleared via the university. Additionally, many members of the team are former captains of their own respective teams, so there is internal expertise as well.
 - 2. "Is there an attendance policy? Additionally, how are the teams made?"
 - a. Answer: To be able to compete in a tournament for the week, an individual must be at two practices for the week. In regard to the teams, the club attempts to fairly and evenly distribute who plays as much as they can.
 - 3. "What would recognition mean to you?"
 - a. Answer: recognition would allow this club to grow, both with members and in quality. The potential funds that could be acquired through SGA would go to new equipment as well as transportation, and attachment of SGA onto a club has great power with recruitment.
 - 4. "Does the team already have amenitites?"
 - Answer: The team does have equipment, and currently carpools via team members' vehicles to games. This is a system that would be refined upon recognition.
- iii. Speaker One For Hofstra Women's Softball
 - This is a positive means for Hofstra students to stay involved within the campus and also stay physically active. Hofstra students typically enjoy club sports and this would be no different, especially with previously-seen traction.
- iv. Speaker One Against Hofstra Women's Softball
 - The rigidity of the schedule is offputting for recognition; the club should not be recognized now, but rather later when it has become more organized and established.
- v. Speaker Two For Hofstra Women's Softball
 - Based on Title IX mandates, since the Boys Club Baseball team is recognized by SGA, the softball team should have the same privilege.
- vi. Vote to Recognize Hofstra Women's Club Softball
 - With a vote of 13:4:4, Hofstra Women's Club Softball will now be recognized by Student Government Association.

d. Gala Update:

- SGA has the opportunity to send 10 members to the 20th annual Hofstra University Gala. Senate will write down the names of 10 members in SGA they vote to send to Gala to represent SGA and those members will be notified of their nomination.
- ii. The Hofstra University Gala will take place on Thursday, May 5th. Ten SGA members will be attending the event.

IV. Vice President Updates

- a. Student Leadership Awards
 - i. Most Accomplished New Club description edited
 - ii. Most Inspiring Student Leader description edited
 - Each description will be placed online for a public vote, which will be condensed to the top five honorees of each category. At this point, each club will bring a representative and each leader will attend the official awards ceremony.
 - 2. Drafts of design for award plaques pending.
 - 3. Nomination form will be live on Hofsta.edu/HSLA as of March 2^{nd} , and will close on April 2^{nd} . Nominees will hear back soon thereafter, and the awards ceremony will take place on May 1^{st} from 2-5 PM.

V. Club Congress Feedback

- a. Preferred Aspects of Club Congress
 - i. Chairperson Shepherd: Breakout sections were efficiently prepared; contact information was well-done; noted importance of punctuality;
 - ii. Vice President Gallagher: Chairperson Solis' introductory speech was excellent; SC 140 rooms were a preferable placement to previously used rooms.
 - iii. President Guarino: Lack of technological issues was advantageous to the congress.
- b. Things to Improve for the Next Club Congress
 - i. Chairperson Mishkin: Turnout was relatively low due to asymmetric information about mandatory nature of clubs.
 - ii. Chairperson Solis: Note that many club leaders assumed that email sent via GetInvolvedHU was SPAM, as opposed to being a valid invitation.
 - 1. President Guarino: Although there are no direct repercussions to having a club not attend Club Congress, there will be future measures of accountability in the future.
 - 2. Vice President Gallagher: Communication ,follow-through is an issue; suggests that multiple emails (requiring response) be sent to the clubs prior to events.
 - iii. Chairperson Shepherd: Wishes to improve span of social media; chairs should distribute and allocate fliers, whereas the jurisdiction of Public Relations is solely for the creation of advertisement of materials.
 - 1. President Guarino: new calendar for planning
 - a. One month before date: Have all logistics planned
 - b. Three weeks before date: All advertisements/PR campaigns completely drafted
 - c. Two weeks before: Print/prepare/post all advertisements.

- c. Advised that each cabinet member read the entire constitution, as well as individually relevant series of information.
