Edits to Appropriation Section of the Policy Series

Allocation Policies:

a. A maximum of five percent (5%) of the funds that are to be allocated to Student Government Association recognized clubs and organizations each ~~year~~ **semester** may be allocated to undergraduate non-Student Government Association organizations if the organization meets the following criteria:

- i. The non-Student Government Association organization must follow all Appropriations policies in order to receive funding.
- ii. Funding will only be allocated for campus-wide events, not for items or programs that are specific to the organization exclusively (i.e.: t-shirts, banners, conferences, travel, etc. will not be funded).
- iii. ~~Fundraisers~~, Charitable events, or items for such events shall not be funded.
- iv. Proposals may be submitted for review over the bi-annual Budget Weekends and weekly meetings

b. Student Government Association will not fund any club or organization that is not registered on GetInvolvedHU. If an organization is deemed inactive for failure to re-register on GetInvolvedHU or for other reasons, they would no longer have Student Government Association recognition and would have to reapply through the registration committee.

- i. The Appropriations Committee shall not fund any club that is deemed inactive by the standards set forth in this Policy Series; and/or
- ii. By the definition of the club category set forth by the Office of Student Leadership and Engagement (OSLE).

c. The Appropriations Committee shall not allocate funds for inventory exceeding the price of \$100 per item unless the club has an appropriate location on campus to store it.

d. Cost Restrictive Policies:

- i. Formals: The Student Government Association shall not allocate funds for formals or any part of formals (i.e. buses, hotels, etc.).
 1. Formals shall be defined as end of semester gatherings held at HofstraUSA, Hofstra

University Club, and any off-campus location.
The Appropriations Committee reserves the right to determine whether or not an event is a Formal.

ii. Retreats: **A retreat shall be defined as an internally planned, overnight stay at an off-campus location that is exclusive to only the members of a club or organization.**

- 1. A maximum of fifteen (15) members, up to \$50.00 per member, may be funded by the Student Government Association for a retreat per semester.**
- 2. No Student Government Association budget shall be allocated for food for the retreats.**

iii. Scholarships: The Student Government Association shall not allocate funds for scholarships.

iv. Alumni: The Student Government Association shall not allocate funds towards any gifts or items for alumni.

v. Licensing/Certifications: The Student Government Association shall not allocate funds for licensing or certifications.

vi. Transportation: Transportation may be funded up to a 300-mile radius of Hofstra University, with the exception of the Colonial Athletic Association tournament bus(es) that is sponsored by the Student Government Association.

1. A Student Government Association recognized club or organization may be funded up to five (5) cars per event.
2. Student Government Association cannot fund gas expenses.
3. Student Government Association cannot fund for coach bus(es).
4. Student Government Association cannot fund Taxis, Uber, Lyft, nor independent travel service (rentals).
5. Student Government Association funds mileage based on the standard Internal Revenue Service (IRS) rate at the time of requested funds.
6. Student Government Association cannot fund Airfare.

vii. Clothing: No apparel shall be funded above \$15.00 per member per semester.

1. Clothing shall be defined as any apparel relating to shirts, jackets, pants, etc. branded or otherwise created for members of a club/organization.

viii. Uniforms: No uniforms shall be funded above ~~\$20.00~~ **\$25.00** per member per semester.

1. A Uniform shall be defined as a distinctive item or set of clothing that is created exclusively for members of the same organization or club.

ix. Prizes: The Student Government Association shall not fund prizes.

x. Tipping: Organizations cannot use Student Government Association allocated funds for tipping.

xi. Disc Jockey: Organizations shall not be funded more than \$500 for Disc Jockeys per semester.

xii. Coaching or Instructor Fees: The Student Government Association may fund up to ~~\$2,500 per year~~ **\$1,500 per semester** for coaching or instructor fees.

xiii. Food for General Meetings: The Student Government Association shall not fund for food at the general meetings of any club or organization.

xiv. Fashion Shows: The Appropriations Committee shall not allocate funds to requested fashion shows unless they fulfill the explicit purpose of the club or organization as stated in their constitution.

xv. Speaker Fees: The Student Government Association may fund specific speaker fees, but not optional honorariums or donations.

xvi. Donations: The Student Government Association shall not allocate funds for cash or in-kind donations.

xvii. Member Gifts: The Student Government Association shall not allocate funds for gifts to members.

xviii. Social Outings: The Student Government Association shall not allocate funds for social outings.

1. A social outing shall be defined as any event that is restricted to the members of a club or organization that does not specifically relate to the purpose of said club or organization.

xix. Hotels: Three (3) different bids shall be provided before any allocations are to be disbursed for hotel costs. A Student Government Association recognized club or organization may be funded up to \$120.00 per room per night for hotels.

1. One bid shall be accepted in the event that a club or organization is mandated to stay in that hotel by the conference or event they are attending. Should this be the case, the club or organization must provide documentation.

xx. Student Government Association shall not fund for Airbnb or independent homestay service (rentals).

xxi. Membership Fees: The Student Government Association shall not fund membership fees for the individual members of any club or organization.

e. Conferences: A conference shall be defined as an overnight stay at an off-campus location, planned by a third party, and is open to all students.

- i. A maximum of fifteen (15) members, up to \$100.00 per member, may be funded by the Student Government Association for registration to attend a conference per year **semester**.
- ii. No Student Government Association budget shall be allocated for food for the conferences.

f. Competitions:

- i. When requesting funds for a competition, an organization shall present the Appropriations Committee with all necessary registration materials and information regarding the competition.

g. The Student Government Association may fund club sports according to the policies set forth by the Department of Recreation and Intramural Sports.

h. Budget Appeals: In the event that a club or organization finds the allocated funds to be unfair, they may file an appeal to be presented to the Senate.

- i. Weekly Meetings: If a club or organization wishes to appeal an allocation from a weekly meeting, the club must email the Appropriations Chair within 24 hours after the start of the Appropriations meeting stating their reason for appeal. The Appropriations Chair must notify

the Vice President that a club wishes to appeal twelve (12) hours prior to the Senate meeting. The club may present their appeal at Senate during the presentation of the weekly Appropriations report.

ii. Budget Weekend: If a club or organization wishes to appeal an allocation from budget weekend, the club must email the Appropriations within the time allotted time specified at the discretion of the Chair requesting a time for the meeting. The Appropriations Chair shall email the Vice President the list of clubs that are scheduled to appeal twelve (12) hours before the Senate meeting.

iii. ~~Clubs or organization shall not bring additional information to Budget Appeals.~~

i. Student Government Association Club or Organization Budget: All monetary contributions donated to the Student Government Association Club or Organization Budget, a subdivision of the Student Government Association Budget, shall only be accessible to the Appropriations Committee. The committee shall be permitted to appropriate such additional budget to clubs and organizations in accordance with the rules and regulations of the Student Government Association By-Laws and Policy Series. In cases where donations are made to a specific Student Government Association club or organization, these funds shall be deposited through the Office of Student Leadership and Engagement and designated as income.

j. Consistency: The criteria that is set forth on the limits of what the Student Government Association may fund, shall be held objectively on a consistent basis.

2. Senator Jackson: I agree with a previous speaker. Even though there is a limit, the \$30 doesn't seem like too much and we should be flexible.
- ii. Speaker against: Chair Liebowitz
 1. I have no voting power with allocations but I recommend creating a precedent over the \$1500 number so we do not play favorites or get exceptions. We want to be equitable and be as fair as possible.
 2. Senator Kang: Even though it is \$30, if you look at clubs on a case by case basis, we don't want to be unfair just for this club. We try to hold the same standard.
- iii. Speaker for: Chair Germaine
 1. Like previous speakers, we have allocated a lot of money for other clubs and a big part of our budget goes to club sports specifically, and since this is not a club sport we could make the exception. We have been lenient in the past and we should be more lenient.
 2. Chair DeBiso: We are not in a deficit and we have money to give to clubs. \$30 is not a lot more and we should give them the exception.
- iv. Speaker against: Senator Annibali
 1. We have the policy series for a reason and if you have a problem with them, we can go through a process and change them. This is the limit and we should continue upholding the precedent and it wouldn't be fair to previous clubs to allocate more money to this club. Sitting on this committee, appropriations discusses what is best in scenarios like this and clubs are expected to abide by the policy series.

2. Comptroller Kaludis: They have their own income in addition from fundraising which they have enough money to cover that gap. Changing the rules makes things tricky and opens the door to changing the rules in an unfair way.

Wednesday, Nov. 17
MPR West

Senator Panagiotidis: Welcome to the Advocacy Forum! You can ask the committee chairs questions about their initiatives, provide feedback, and make suggestions for future initiatives and make your voice heard! Please take the SAW survey if you haven't already.

Chair Campbell: Ask me any questions about academic affairs.

Chair Germaine: Ask me any questions about inclusivity, identity, or feeling marginalized.

Chair Singh: I work with compass dining, renovations on campus, and facilities and operations. Ask me questions!

Chair Funk: Is everyone okay with being on camera? I'm taking a boomerang for the instagram takeover. I work with public safety, and student health and counseling services. Ask me questions about these services! Introducing special guest: public safety community outreach coordinator, working on engagement with students in the community.

Senator Panagiotidis: Upcoming SGA programs! Build-a-friend, kind of like build-a-bear, it is Wednesday 12/1 from 5-7pm in the Mack Arena before the basketball game. Holiday karaoke, cookies and cocoa on 12/7 from 6-8pm in the multipurpose room.

Senator Quezada: What are your committees working on this semester?

Chair Campbell: Working on including 18th credit in tuition because we only include 17th right now. Working on accessibility and zoom options in the classroom. Working on programming to help faculty with using online resources. Work closely with professors and admin to make sure student needs are met.

Chair Germaine: Partner with IEI and identity based clubs, collaborating on events, working on making EthicsPoint more well known. It is currently in the waffle icon and students don't realize.

Chair Singh: Working on renovations on campus, working closely with admin, renovating in terms of accessibility so students can succeed. Working on a touchless card system. Working with compass dining to make food better on campus and making sure student voices are heard. Working on making Hofstra more sustainable.

Chair Funk: Working on helping p safe connect more with students, discussion based idea for getting feedback from students. Helping students feel safe on campus. Showing students what resources we have. Counseling offers FREE therapy and there is a free flu shot clinic. We work with Title IX and It's On Us, and the safe center. Helping bystander prevention. Making sure students are safe.

Student: Why don't we get the 18th credit in the first place? What is keeping us from achieving that?

Chair Campbell: We must still figure out what we are modeling this off of with the financial aid office, in terms of comparable schools. The 84th Senate made a proposal and it was rejected, trying to figure out why with new administrators. Science and engineering majors often require the 18th credit, this is affecting retention rates of students. Hoping to get it passed this year.

Senator Patane: How will this affect liberal arts majors if we are focused on science majors?

Chair Campbell: We will still be focusing on that. Allowing students to have more opportunities in science since Hofstra has been traditionally focused on liberal arts. Want everyone to have the same opportunities.

Senator Perez: A student approached me with a concern about a LatinX professor being stereotyped and facing discrimination. He has decided not to return next year. What more can we do to protect students and faculty from discrimination?

Chair Germaine: I work with our chief diversity and inclusion officer Cornell Criag who focuses on equity and diversity. He has been working with departments on having equity training. SGA wants clubs to go through equity training, we will be working on implementing this next semester. The EthicsPoint reporting system allows students who experience bias to report it anonymously or non anonymously. This also works for faculty experiencing bias concerns. The Provost office will also work on investigating.

Student: Some elevators don't go all the way to the top floor. A friend had a knee injury and had to take a leave of absence because it was so difficult to get to class. Hofstra doesn't accommodate disabled people as much as they should. (example: eye tracking for ADHD) Are you going to try to implement more accommodations to this community?

Chair Campbell: Academic affairs has been working closely with Julie Yindra, working on getting eye tests taken down. Working on having students ask for accommodations when needed. Trying to implement a strict policy to get professors to listen to students who request accommodations.

Chair Singh: I'm sorry this happened to you. Recent meeting with Julie Yindra, putting together a list of non-accessible things to fix. One was getting an elevator to the thirteenth floor. Big project but would be very beneficial.

Student: I know people who have had life long learning disabilities but you need to be tested within 3 years to get accommodations. This is not accessible as tests can be very expensive and disabilities linger even if they don't show up in a test.

Chair Campbell: Working closely with Julie Yindra. Making it so if you filed for accommodations in high school it can transfer over. Agree that tests are way too expensive. Must work on changing policy, probably won't be able to change it yet but will lay the foundation.

Senator Staderker: There is a new public safety director. What has public safety done to bridge the gap between public safety and students? Many students have had bad experiences interacting with public safety.

Chair Funk: Met with public safe recently. Planned on making meet public safe events and adding photos of the officers on the website so it's easier to recognize them.

Giovanni (public safety director of community outreach): I am new to Hofstra. The new public safety director has prioritized bridging the gap between students and public safety. My role as the community engagement and outreach person will be responsible for this. Students can reach out to me with any ideas, complaints, etc. Moving forward starting in January there will be one day a week where the director is available to meet with students in the student center to ask her questions. Will have series on learning new things like changing a tire. Moving away from the stigma of public safety.

Chair Funk: Working with Julie Yindra to work on more neuro-diverse training. Also walked through the new SGA office that all students are welcome in, and had great conversations with students. Public safety should be a place students feel comfortable to go to.

Anonymous question: lack of covered bike racks around campus. Only one at Nassau-Suffolk, others do not have covers. How will Hofstra make it easier to find accessible bike parking spaces?

Chair Singh: Committee has been discussing bikes for awhile and these racks are needed. Looking into getting more bike racks and bike rentals on campus for those

who can't bring bikes to campus. Bringing this up to admin and working on a plan this semester.

Anonymous question: How will SGA help clubs get funds to keep operating? Will they allow funds to carry over to next semester to help clubs rebuild after COVID?

Comptroller Kaludis: Hi! My role is to oversee all financial records for clubs. Want to put on everyone's radar, we gave out blanket allocations this semester which is essentially free money. Moving forward, we do budget weekend where every club submits a budget to appropriations and we approve or deny. From fall to spring, any leftover funds will still be in your account and will roll over. For those who requested a budget this semester, we are still working on them and you will get the money soon. We will be more than happy to fund given proper paperwork and quotes. Please reach out to me with any questions. Clubs should not be worrying about money and we will do our best to fund you.

Anonymous question: More could be done to advertise events such as this forum.

Chair Doherty: I run our social media accounts and make advertisements for events. Coming out of last year where in person advertising wasn't seen, we are working on more advertisement but find it faster and more efficient to do on social media. Working on getting more in person moving forward.

Chair Germaine: If you reach out to SGA_clubresources, our CR chair Maxie DeBiso works hard to have all club events included in Senate minutes. If you have a club event or a game, DM our instagram and we will be more than happy to post it.

Student: Been having trouble keeping track of events. A lot of things are posted but it is difficult to organize them. Event schedule was recently put in my dorm. Will you be working on something like this?

Chair Doherty: A little all over the place this semester but next semester we will have a more solidified schedule of programming for the semester.

Chair Funk: There is a calendar with events near Student Center 260, such as the Red Hawk Event on Monday. Around this area and the PPAW you can find flyers and calendars.

Chair Germaine: OSLE sends out the This Week at Hofstra email every Thursday which is a great way to find events at Hofstra. Takes every event and condenses it into a list and sends it out to every student. Make sure to submit events to OSLE.hofstra.edu to have it be put into the email.

Chair Campbell: We have had many things be pushed back because of COVID. We currently don't have access to our usual bulletin board so all we really have is social media and word of mouth right now.

Student: What comes every Wednesday?

Chair Funk: The Plan Van comes every other Wednesday from 11-2 and offers free HIV and STD testing. Located in West Circle Lot near Stuyvesant. Tests take 20 minutes and you get rapid results. Also give you a safe sex package and information on HIV. PREP is medication that helps stop the spread of HIV if you or a partner have HIV.
