 - a. Chair DeBiso: You submitted three quotes, is that the lowest cost?
 - i. It was the average.
 - b. Senator Valasquez: For the hotel, is this paying for the entire team?
 - i. Yes this would be anyone who is going. The entire team does not always make every tournament.
 - c. Chair DeBiso: It is 4 rooms for each of the tournaments?
 - i. Yes.
 - d. Chair Liebowitz: Do you have correspondence from your coach and know their fee?
 - i. I can find out.
 - 1. Chair Liebowitz: Senate can choose to view the policy as you wish in terms of the hotel. It hasn't been the precedent of the committee under my chairmanship, but since we have knowledge of dates and the areas we would normally look at the same dates and areas. Would not be out of line with what the committee has done in the past.

2. Comptroller Kaludis: I would remind everyone that even if we don't fund during this meeting we can fund later on or they can fund from their income.
3. Chair DeBiso: How much money do we have left that we can allocate?
 - a. Comptroller Kaludis: I will look into that.
4. Senator Behm: That is the highest amount correct?
 - a. Chair DeBiso: Yes.
 - b. Chair Liebowitz: Asking how they got their number may be a waste of time.
5. Senator Jackson: We should fully fund this.
6. Senator Liebowitz: If we do that we should ask where their number came from.
7. Senator Annabali: We should be mindful of how we are spending our money.
8. Chair Doherty: Think about a few weeks about previous debates.
9. Chair Funk: Can they spend allocations on other things?
 - a. Chair Liebowitz: Yes they can through the reallocation process.

 1. Motion objected
 - a. Speaker for Chair Doherty: I am a big supporter of precedent. If this is the largest amount we can allocate, then this is fair. It is a slippery slope with clubs.
 - i. Chair Germaine: Keeping the \$120 would be equitable.
 - ii. Chair Funk: A previous speaker mentioned that we

should think about how we are spending money.

- iii. Chair Doherty: we establish ourselves by following the policy series.
- b. Speaker against Senator Annabali:
Even if there is a precedent, we could be funding more than a quote shows. If we have the correct numbers we could have a quote with the correct amount.
 - i. Senator Egolf: Even though we have one under it, then if there is not another quote \$120 then they may not have the correct information alongside our policy series.
 - ii. Comptroller Kaludis: They have \$300 left from this semester to roll over.
- c. Speaker for Senator Stadeker: Like another speaker said, the \$120 is the max in the policy series then that would be fine. Going over it is not a good idea as we need to respect precedent.
 - i. Chair Doherty: There could be cheaper options but it gives us more reason to give them the most we can. We work within the policy series and have good relations.
 - ii. Chair Germaine: People book in advance and it is better than making them wait and potentially have them spend more.

- iii. Chair DeBiso: First day of class is January 31 and that would cut it close.
 - d. Speaker against Senator Siegel: As the policy series says they need the correct information which they did not provide us with.
 - i. Senator Valasquez: We do start on Jan 31, but in the best efforts we should wait and have them come back.
 - ii. Comptroller Kaludis: The unspent money stays in their account and they come back to SGA at the end of the year.

 - d. Chair Doherty: Do you have three concerts per year or per semester?
 - i. Per semester.
 - e. Senator Stadeker: For the food, you spend \$100, do you know the quantities for each food item?
 - i. 2 pizza pies and the rest of the food would be totally \$100.
 - f. Chair Liebowitz: Have you ordered from Gino's with SGA funds before?
 - i. Yes I believe we have.

1. Senator Stadker: What is the precedent for the lack of funding?
 - a. Chair Liebowitz: We calculated the pizzas.
2. Chair Doherty: The way Hofstra is doing it does the prepackaged food include pizza?
 - a. Chair Liebowitz: Based on whether it is an authorized vendor.
3. Senator Boothe: For the mic stand, do we usually give leeway or stick to the specific amount?
 - a. Chair Liebowitz: Yes we stick to the specific number.
4. Senator Stadker: Same question about Spotify?
 - a. Chair Liebowitz: Yes, the specific amount.
5. Senator Perez: Are they getting two mic stands?
 - a. Chair Liebowitz: Both quotes do include a mic stand for a total of \$168.99.
6. Chair Germaine: Have other acapella groups come to appropriations for the product in the past?
 - a. Chair Liebowitz: Yes.
7. Senator Behm: The cost for this is being split amongst the various acapella groups.
8. Senator Givens: We could ask if they need one mic and two mic stands.

SGA Club Recognition and Derecognition

- a. STUDENT GOVERNMENT ASSOCIATION RECOGNITION AND DERECOGNITION
 - i. Clubs will be SGA recognized during the OSLE recognition process.
 - 1. Fraternities and Sororities as well as Graduate organizations will not be eligible for SGA recognition.
 - ii. An SGA one (1) representative from all four (4) logistics committees and all (4) four advocacy committees will sit on OSLE club recognition meetings.
 - 1. If a senator is chosen to sit in on the meetings this will replace the office hour for that week.
 - 2. Senators will attend these meetings on a rotating basis to ensure all senators have an opportunity to sit in on the meetings.
 - 3. Minutes will be taken at these meetings and will be presented to all of Senate by the Club Resources Chair.
 - iii. Clubs who are recognized will be able to apply for a budget with the exceptions of fraternity, sororities and graduate clubs.
 - 1. No recognized club is guaranteed a budget.
 - 2. For more information regarding eligibility for a budget can be found in the Appropriations section of the Policy Series.
 - iv. Clubs will need to meet the following criteria to be eligible for club recognition through OSLE and SGA:
 - 1. Shall comply with all local, state and federal laws.
 - a. Clubs and organizations must comply with the university's anti-hazing policies.
 - 2. Shall be open to all students.
 - 3. Shall maintain a minimum four (4) person E-Board consisting of President, Vice President, Secretary and Treasurer.
 - 4. Must complete all mandatory trainings and requirements.

5. Meet with your assigned administrative advisor twice (2) a year.
6. Log all community service hours through the Community Service Tracking Form located on GetInvolvedHU.
7. Follow a constitution having been approved by the Club Resources Committee and Senate that contains the Student Government Association's most current preamble.
8. Attend a Student Government Association Club Resources Committee meeting to review the club constitution.
9. ~~Following approval of the club constitution by the Club Resources Committee, the club or organization must attend a Senate meeting to seek recognition.~~
10. Maintain a membership with no more than half being members of a currently banned or suspended Hofstra club or organization.
11. Maintain an updated and approved GetInvolved HU profile.
12. Clubs and organizations shall hold a minimum of three (3) meetings with at least fifteen (15) members in attendance prior to seeking recognition by the Student Government Association. The Club Resources Committee shall require proof of such attendance in the form of attendance rosters for at least one (1) such meeting in that semester.
 - i. The Club Resources Committee shall require the submission of this roster at the meeting for club constitution review.
 - ii. The Club Resources Committee shall verify that the members present at said meetings are registered on the club or organization's GetInvolvedHU page.
13. Prior to becoming eligible for recognition by the Student Government Association, organizations shall host at least one (1) fundraiser and/or event, per the discretion of the committee. The Club Resources Committee may request proof¹ of such fundraisers/events if deemed necessary.
14. Clubs and organizations recognized by the Student Government Association shall be permitted to request funds at a weekly Appropriations Committee meeting within the same semester in which they are recognized.

¹ Proof may be defined as receipts, fliers, email confirmations, rosters, etc.

Newly recognized clubs and organizations are immediately eligible to submit a budget proposal for the upcoming semester.

v. If the club fails to meet all of the requirements listed above, it will result in derecognition of the club.

vi. —An active club may seek Student Government Association Recognition if it abides by the following guidelines:

~~b. STUDENT GOVERNMENT ASSOCIATION DERECOGNITION~~

i. —The Club Resources Committee reserves the right to derecognize previously recognized clubs and organizations based on the following criteria:

1. Active club membership falls below fifteen (15) members on GetInvolvedHU.
2. Active member attendance falls below a consistent average of fifteen (15) members at general club meetings and/or events.
3. A minimum of three (3) club-related events are not held during any given semester.²
4. A club does not utilize Student Government Association services³ above those required of the Constitution and Policy Series for one (1) full academic year.

~~c. DEFINITION OF DERECOGNITION~~

i. —Clubs and organizations that have been derecognized shall no longer be permitted to identify themselves as recognized by the Student Government Association. In addition, said clubs and organizations shall not be permitted to request nor obtain the following Student Government Association resources:

1. Funds outside of the five percent (5%) legislation available to non-recognized clubs and organizations.
2. Advertisement per the Communications Committee.

H. REACTIVATION PROCESS

d. Clubs and organizations that have been deactivated and who are seeking reactivation shall follow all guidelines laid out in the Student Government
