i. The Judicial Panel seems fit to officially impeach Club Resource Chair Kashmiraa Pandit. Judicial Panel would like to thank Kashmiraa Pandit for her service as both Senator and Chair and her dedication to SGA.

b. Provost Riordan Visits Senate!

ii. Provost Riordan: We have been working a lot in Equity, inclusion and diversity. Things are ever evolving and we have been focused on people! We have been working hard to hire new deans for the colleges for both HCLAS or HPLAS, hiring new faculty (between 25 to 30 new faculty in the fall), and we are very excited to be offering these positions. For our law students, we will be searching for a new dean for the law school and will start that in the fall. We are starting some new projects in the library. We have gotten opinions from three amazing people and they are dreaming of a wonderful future for our library. There are a lot of very dynamic things that can be done on campus and they have heard alot about what can be done to improve our spaces and to enhance the space/programming done in the library. Separate but related, we have, as a university, brought in a space consultant. They are being asked to look at the library and to see how to make the space look

more collaborative and inviting for students who use these spaces. I believe that our consultant is really good at planning new ideas for these spaces and will be functionable and pleasing. Another thing we're working on is that we, along with Poser and her cabinet, have been working on seeing what is distinctive about the Hofstra academic programs. This exercise is designed to invest in creativity and energy within the curriculum at Hofstra. Around the end of December we asked faculty to see with extra resources how the deans could enhance their academic programs and how multiple disciplines could be brought together in innovative ways, so that students could be interested. The programs would be engaging, and allow for us to learn how to address societal problems. The wicked problems of the world will not be solved by one person. If you do not understand the social and policy aspect then you may not be able to convince the people. What we're doing with these proposals is asking staff to come up with new ideas to make academic programs more engaging, and give students skills that everyone needs to be successful. By the end of March all proposals will be submitted, the committee will review them and by the end of the semester we will identify these projects and see which ones we will fund. There are some ideas that are big and small and allow us to think about what makes Hofstra special.

- 1. Chair Giovanangelo: "I know we have discussed the 18th credit previously! What updates do you have regarding this and how can SGA help! Are there any other initiates we can help you with!"
 - a. I appreciate the question and to tell you where we are right now, SGA is looking at this issue and has been doing a lot of research. There is a group of faculty (UAAC) and the Provost office who are all looking at this. Each group is giving new perspectives on this issue. We would like to bring all these groups together on this issue. Recently in UAAC they have done their first phase of research, and it was primarily focused on majors across Hofstra and their degree requirements. We have a range of 120-136 credits to graduate depending on major and if there is a test required at the end of your coursework. The way I am thinking about the 18th credit hours is an important issue that is a part of the bigger topic, that is, how do we ensure our curriculum is set up so that all our students can

graduate in 4 years. I know that the national numbers show that more than 50 percent of students in college change their major. Exploration is a good and positive thing and 18 credits could help with that.

- 2. Chair Jackson: "What does your day to day as Hofstra's Provost look like?"
 - a. So I wake up early around 5:30 AM and come to campus. It's about a 15 min drive. 7-9 is my time to think and get some work done. There are a lot of meetings throughout the day as well as events. Such as Tuesday which had a lot of Board of Trustees meetings. Most of my time here is spent on people. I am very busy almost every day. I have many meetings and are doing
 - i. Chair Jackson: "What has been the highlight of your time here at Hofstra (so far)?"
 - 1. I have a few moments that have been my favorite. I loved Colin Jost. It was great to watch students be engaged and enjoying themselves. I enjoy events that are intellectually engaging such as Civil Rights Day. I really like to do lectures. I go to a lot of the athletic events. I just love walking around campus and walking over the unispan when classes change. It is a great community of people.
 - ii. Chair Jackson: "What are your long term/short term goals for Hofstra University?"
 - 1. My goals are specific around what makes Hofstra academics special. There has been a lot of change in recent times especially during the pandemic. What I hope happens in 5 years is that higher education all around looks at Hofstra and thinks "We need to get to Hofstra because they prepare their students well".

Special Accommodations to Presidential and Vice Presidential Elections

Taken from Article X, Section B of the Policy Series

A. ELECTION OF PRESIDENCY AND VICE PRESIDENCY

- 1. All presidential and vice presidential candidates shall run as a ticket. If either the presidential and/or vice presidential candidate does not meet the requirements stated in the Student Government Association Policy Series, or are unable to continue their candidacy, the remaining eligible member of the ticket shall have up to seventy two (72) hours to pick a replacement.
- 2. The Elections Commission shall only see a new ticket composed of at least one (1) candidate from a previously disqualified ticket.
- 3. Candidates for President and Vice President are to be elected on separate ballots, though one Presidential campaign may be run in coordination with one Vice Presidential campaign.
- 4. If an electorally unsuccessful ticket candidate receives the minimum number amount of votes for Senator at Large, the candidates shall be offered may choose to be elected to the position of Senator at Large.
- 5. On a date(s) specified by the Elections Commission, candidates for President, and Vice President, Senators, and Justices must attend a meeting to declare their candidacy.
 - a. If a student cannot attend this meeting, they may email a member of the Elections Commission twenty-four (24) hours prior to the meeting with their name, 700 number, email address, and the title of the position they would like to run for.
- 6. Candidates for President and Vice President must have collected the required signatures at a separate and earlier date than other offices.

- a. This date is to be specified by the Elections Commission and cannot be later than the first Monday of April.
- b. Only candidates who have collected the required signatures by this separate and earlier date may campaign, participate in debates, and appear on the ballot.
- 7. Candidates for President and Vice President are to be afforded an extra week of campaigning in the interest of increasing awareness of candidates and facilitating debates between candidates.

Expansion of Debates

Taken from Article X, Section C Subsection 3 of the Policy Series

1. DEBATES

- a. Any questions relating to the debates shall be directed to the Elections Commission and answered outside of the Student Government Association office.
- b. If there is an uncontested election, the Elections Commission shall hold at least one (1) event during which the ticket candidates present the goals of their campaigns to the general Student Government Association constituency prior to voting dates.
- c. The Elections Commission shall organize at least one (1) **presidential** debate **and one vice presidential debate** if **each office sees a competitive election.** There is a contested election.
 - i. Debates are to be open to the Student Government Association constituency.
 - ii. The format and logistics of debates shall be left to the discretion of the Elections Commission but the following provisions must be adhered to:
 - 1. The debate must occur before elections begin and after signatures are collected for president and vice president.
 - 2. The debate must feature at least one (1) non-partisan, non-SGA moderator.
 - 3. Every effort must be made to include all candidates for each respective debate.
- d. A ticket debate shall be held prior to voting dates. The Elections Commission may hold two (2) additional debates prior to voting: a presidential debate and a vice presidential debate.

- a. Doctoral Research Study Presentation by Kristen Klein (kklein14@pride.hofstra.edu, (631)-903-9549
 - i. Doctoral candidate and working to spread the word about her study. The study surrounds students with disabilities and the influence of student-faculty interactions on grade-point average. I am looking into this for a few reasons, only 4.6% of higher education include disability in their mission statements, disability is on the rise on our college campuses, about a 13% increase, and only 1 in 3 students will disclose their disability status. As well it is important to note that there is not a lot of work into the study of disabled students within higher education. In my study, I am looking at all different types of disabilities, and those who participate do not have to have a diagnosis. To participate in the study, you must be an undergraduate student at Hofstra who

identifies as a disabled/person with a disability, you do not need to be registered with student access services adn it is anonymous and confidential. It will be a survey sent out to students and also accessible through a QR code, and it will be accessible online. It will be made up of 3 parts. There will be benefits to those who participate which are as follows, you will have contribution to literature on students with disabilities, raise awareness of challenges, faculty training and much more. I would like to have the assistance of SGA as you can help me with our students.

- 1. Chair DeCresenzo: Do you have any campaign ideas to highlight your study?
 - a. I have flyers that detail the study and I am hoping to have the study out for between 2-4 weeks.
- 2. Chair Jackson: What do you think SGA could do to advocate for resources?
 - a. For now, I would say Student Access services is very open to advocate for students. I think advocating for support of their office and I think promoting the ability for SAS to help even without documentation.

b. Equity & Inclusion Committee Spotlight!

- i. We work closely with IEI and our chief diversity officer. To promote all the identities that we have on campus, we have been focusing on programming. We have had queer at hofstra, black at hofstra, and even latinx at Hofstra. Black at hofstra was a second year running program and we have both women at Hofstra, disabled at hofstra and AAPI at hofstra coming in the next few months. If you ever have an issue that you see on campus that you believe I should be aware of, please do not hesitate to reach out to me. It is a lot of help when others can help me with this as I am only one person and want to make as much widespread change as possible.
 - 1. Senator Tauro: How do you do it?
 - a. I attribute it to my mother and looking at all the work you all do.
 - 2. Chair Stadeker: One of my associates has asked about professors handling religious observance absences, and we wanted to know if there had been any progress on this?
 - a. To my knowledge, Provost Riordan has not gotten to me but I have taken with Office Craig. I am hoping to circle back to this issue not only through meetings but also with our upcoming SAW survey

- as well. Bringing this back, we hope we bring this conversation to the forefront again
- 3. Gallery Member Boothe: I love the identity based programs, the @ Hofstra series and want to know where they will be going.
 - a. I am hoping to keep these being put on as it was a goal of my predecessor and I am hoping to be able to ensure they will happen for years to come.

- i. Chair Anniballi: The reason we have decided to do this was to come to this consensus as this would be for the benefit of the Senate and it would create more competitive elections. We wanted students to be able to vote for the candidates that they see as their own preferred candidate.

- differences whether on Senate or Eboard to make a strong SGA. We are here for the student body, not the position.
- v. Comptroller Fountain: My first point is based on a previous speaker. I'm all for increasing competition, but with this SA, my biggest issue is the process of elections and campaigning. With this everyone could vote for anyone running for President or Vice President, but then in an election you only choose one candidate. I don't see how someone can campaign with a precedent like this.
- vi. Senator Livingston: I would like to point out that every signature does not mean a vote.

 Just to get them on the ballot. As a candidate your point is to campaign and run and advocate for yourself to the student body.

 We are not strangers and if you are not able to work with someone there are processes in place to handle that.
- vii. Senator Barone: As to the previous speakers, I think that having a separate ticket would allow for differences of opinion.
- viii. Gallery Member Boothe: In the previous senate, they were not friends before running on the same ticket. They worked during the summer to figure out how they wanted to work together. If you wanted to be Pres or VP you would most likely be running with someone in this room. I believe it is important to keep the ticket together because it is easier as their relationship is important to the whole of SGA.

 - ix. Chair Anniballi: As a previous speaker laid out, really any system will have points that they are weak but we need to remember that just because you can not run officially on the

- same ticket, it does not mean you can not run as a joint campaign. We need to have the President and Vice president to represent the student body and all their complex experiences.
- x. Chair Atlas: To reflect the previous spoken point that multiple people can sign off but not vote for, there could be debates to allow for the running members to present their platform. This could help sway the student body and help them choose the correct candidate.
- xi. Chair Pandit: I want to reiterate the points made. I understand the relationship is essential. But having this diversity allows for more voices and views to be heard. I think the diversity of thought would be very helpful.
- xii. Chair DeCrescenzo: I do not oppose the joint ticket but I would like to see a gap between the packet portion and the election portion. A signature is not a vote but you can sign off on everyone's. I would like to see an extension, something similar to a shadow campaign so there is a gap between signature and elections.
- xiii. Senator Livingston: Something I want to point out is that not everyone wants to be President or Vice President. So in the instance if there is a person who does not have a running mate, I just don't want to silence their ideas because of that.
- xiv. Senator Barone: Running on the same ticket not knowing each other would mean they have to build this relationship. We all have to work together regardless so I don't think having a joint ticket is very essential. And more ideas could be brought because they are different and have separate opinions.
- xv. Senator Egolf: I think we can all agree a signature on a paper is not a vote, but in theory if you could vote for president it

would be the same as everyone can vote for a senator. The odds of them getting the same amount of votes is slim. Even if you could vote for both presidents, it goes that not everyone is voting for everyone.
