 - a. Senator Egolf: Do you know how many hours of rink time that they currently have and what they would have with 75% of their budget?
 - i. Chair Giovanangelo: They would have 23 hours of practice at 50% and to go up to 75%, it would add an additional 7 to 8 hours.

- ii. Comptroller Fountain: For reference, the second highest club got half of what they currently have. Their club has a large amount of income that could possibly cover all these costs. If we fully funded this we would be over what SGA can properly fund. There are multiple factors we took into consideration, but we also had a reason to cap it due to all the clubs on campus.
- iii. Chair Stadeker: I do not know if they do pay a fee but in the majority of the club sports I have participated in, I have had to give money towards the club.
- iv. Senator Barone: There were a lot of issues, but we were good this semester with saving money. I recommended not going above 25000, just because they got a lot more than other clubs.
- v. Senator Egolf: Can you clarify what you mean by a club's income?
 - 1. Comptroller Fountain: Income is something that we have no control over, it never goes away or rolls back like SGA funds. And a club can use it on whatever they want.
- vi. Senator Egofl: In their own income, do you have all if not close to the money they need in income?
 - 1. Comptroller Fountain: I can not say an exact number but it is close.
- vii. Chair Atlas: What would it be if we funded 60% of the budget?
 - 1. Chair Giovangello: It would be an additional \$3,188.09 for 60%.
- viii. Senator Greenlaw: It's a lot of money and it was more than we originally wanted to allocate. That took away opportunities for other clubs.
 - ix. Comptroller Fountain: My recommendation is to keep it at this.

 - I have been here for about 2 months now and want to share who I am and how I got here! I am originally from Mississippi and I always had a vision to work at the Washington Post. Along the way, people urged me to consider other plans and I had an amazing teacher who inspired me. I majored in journalism at Arkansas State and I did end up at the Washington Post. I spent 16 years there and worked through multiple departments and I left due to the internet changing the journalism I knew. I did get to have an opportunity to work with the community while doing journalism as well. I reinvented myself and worked in the DC government. I was a career through one administration and then demoted when the new administration came in. I used the demotion to close a gap, the gap that I filled was the Washington Post. 8 years later, I was still the mayor's communication point. Hofstra then knocked on my door and asked me to do government affairs, and Dr. Poser offered me the position and here I am now. In this role, I feel like there has to

be a connection between my office and the students, whether it is governmental affairs or community. We want our voices to matter and to have our community feel safe. When I leave, I want an establishment that is left behind where administration and students have a strong bond.

- 1. Senator Guenfound: What are more ways for Hofstra to get involved with our local community? Are there any new ideas?
 - a. I personally am learning the area around Hofstra right now, so I am going to meet the Long Island association and more people to gauge where we can aid and how far we can reach. I know you all have classes and are students but I want to make sure that we can get out there and marry it with students to make an impact.
- 2. Chair Pandit: Could you describe how you want your next few years in this position to look like in a few words?
 - a. I would use the words, "learn", "engaging", "chill", "successful", "excited". I want to be able to learn and grow here and have you grow along with me. I want to be engaging to allow our students to talk to me. I also want to be chill because I want to be calm for people and our university. I want to be successful in creating more and more connections and I do not want to be bored. When I become bored, I need to hop and do something.
- 3. Senator Tauro: What message do you have for people who are trying to grow and reinvent themselves?
 - a. Don't be afraid to just try. Don't put yourself in a box where people say this is what you're supposed to do. Do not let others bring you down and do not let others tell you what you are capable of or what you can do. Take the chances. Whatever it is you believe in, hold on to it.
- 4. Senator Egolf: what's your favorite thing that you ever wrote about?
 - a. I was actually an editor at the Washington Post, not a reporter. But I have written things. I actually was in a program where there was a session in Florida to improve your skills. There was a detailed writing

- assignment and mine was about the day I went to the Washington Post but the cliffhanger was that it was also the day I met my husband. We were paired up to read our writing and I loved doing that.
- 5. Senator Egolf: What's the most valuable lesson you learned at each of your past jobs?
 - a. I held on to my convictions through much of my jobs. At the Post, I learned how to be a better manager, and I had a writer that wrote something with an extreme error made to it, but I learned that now when I manage, I advocate for my people extra hard and I go past what the policy says. The DC government taught me the value of partnerships and to be responsive and a good person to others. Hofstra, I will get there.
- 6. Senator Wong: What are some tips that helped you in your journalism career?
 - a. For tips in journalism you need to know how to write. The best way is to just keep writing no matter what. Also read other writers and learn how they craft their stories. Also I would recommend gaining an internship.
- 7. Senator Wong: What is the best piece of advice you could give based on every position you have held?
 - a. It is all in keeping and maintaining relationships and connections. You have to be honest and straightforward.
- 8. Chair Jackson: How did you get into Sports Media?
 - a. There is this program called Sports Media Institute and it was a 2 week bootcamp, that program is still around today. I would love to tell you more about it and we can set up a meeting.

SGA is a resume builder but what resume are you curating, what could the positions you hold do for your resume. I also think knowing what the position does and how you would put your own passion into it. I would also say think about how much you can take on.
