Previously, he was vice president/strategy and development of Tribune Publishing Company, where he oversaw strategic planning, acquisitions and development projects. He helped create and had senior management roles at Classified Ventures (cars.com, apartments.com, HomeScape), an interactive business partnership between Tribune and other leading media companies. Mr. Knight is a "recovering" attorney – he was a senior corporate associate at Skadden, Arps, Slate, Meagher & Flom in Chicago and London before joining Tribune Company as its mergers and acquisitions counsel.

Born in Flint, Michigan, Timothy Knight holds a bachelor's degree in accounting from Marquette University and a Juris Doctor with honors from DePaul University College of Law. He also attended the corporate finance program at London Business School. His community activities include serving on the Chairman's Council for the Heckscher Museum of Art in Huntington, New York, and on the board of the Long Island Association. He also serves on the Tribune New York Foundation Board.
