Internship Program Admissions

Hofstra University's Student Health and Counseling Center's Doctoral Psychology program has two available internship positions, each involving 40 hours of varied clinical and didactic training totaling 2000 hours for the training year. The internship program reviews intern applicants based upon their completed AAPI, cover letter, CV, references, graduate transcripts, and interview data to inform goodness of fit. The program seeks individuals who hail from Clinical or Counseling Ph.D. or PsyD programs, have at least 400 intervention hours, 100 assessment hours, and a breadth of clinical experiences in both individual and group interventions with young and emerging adults. Coursework and practicum/externship experiences in cognitive-behavioral practices and a demonstrated sensitivity to diversity are also highly preferred.
