J.O.2020.85.001 [REDACTED]: Majority Opinion

The constitution of a club is meant to be its guiding document, outlining policies and methodologies that it aims to uphold. It is one of SGA's responsibilities to ensure that clubs adhere to their constitutions. In the case of the [REDACTED], SGA recognizes that the error was not made out of any malicious intent, but rather due to the issue of a miscommunication. Due to the Judicial Panel consisting of only one Justice, the members of Cabinet were asked to fill in for the Judicial Panel.

The Club Resources Chair, Gopal Khandelwal, was contacted by [REDACTED], a member of the [REDACTED] E-board, on the 29th of June, 2020, in an email signed by several other members of the E-board. The email outlined that a specific section of the constitution had been breached, specifically Article IV Section 2, requiring a debate between candidates following a tie. Allegations were also made that [REDACTED], the previous [REDACTED] of the [REDACTED] used slanderous remarks to degrade the character of [REDACTED], a candidate in the election.

Chair Khandelwal met with Denise Boneta, the mutual advisor for the [REDACTED] and SGA, and then held a meeting with the Chief Justice Palak Maniani, SGA President Tara Stark and SGA Vice President Alexa Osner. It was during this meeting that Chair Khandelwal was given the authority to form an Ad Hoc Chronicle Investigation Committee, which dissolved once its function was completed. The Ad Hoc Committee was composed of Chair Khandelwal as well as Senator Kathryn Harley, Senator Michael Hotaling, and Senator Bryan Perez. The Ad Hoc Committee interviewed all members involved that night, and collected over two and a half hours worth of interviews. All of these interviews were handed over for the hearing.

On Sunday, August 16th, the hearing convened with the following members present: Chief Justice Palak Maniani, Academic Affairs Chair Khiya Connolly-Sisk, Communications Chair Antonella Colon, Equity and Inclusion Chair Maria Mobley, Facilities and Operations Chair Bernice Aquino, and Wellness and Campus Safety Chair David O'Brien. The hearing was witnessed by President Tara Stark, Vice President Alexa, Secretary Charlie Greenberg, and Club Resources Chair Gopal Khandelwal.

After extensive deliberation, the Panel came to a decision. Based upon Chair Khandelwal's recommendation, the Panel chose to elect both [REDACTED] and [REDACTED] as [REDACTED], keeping [REDACTED] as [REDACTED]. The Panel chose to keep this subject to the approval of the [REDACTED] E-board and the wishes of all three of the candidates. Should the majority of the [REDACTED] E-board or the three candidates reject this solution, they shall schedule a re-election with the Club Resources Chair as soon as possible.

As per the request of an individual in the investigation, the members of the Cabinet do hereby affirm that they presided over this case with no bias for or against any of the members running or involved in the [REDACTED] or its investigation.
