#### XVI. New Business

#### A. Budget Appeals

#### i. Hofstra Concerts

1. Appeal: They are appealing for 1,100 for music fest. It is a crucial part of Hofstra's culture and the largest student run event on campus. They have always out on a high quality show and pride themselves on their ability to put together a fun event for all. Based on the budget allocated, we will not be able to put on a successful music fest this year. We cannot afford the artists that the students want to see. Production will cost \$30,000, so we have the remaining \$42,000 this year. We cannot afford hospitality, advertising, and hosing costs that are necessary for this event. We are sympathetic to the burden you bear in allocating funds. We are expected to put on a show for all students and can not do that will the budget allocated to us. Despite an increase in the student activity fee, we do not understand why we cannot receive the same amount we did last year. We would like an increase in \$1,000 for advertising materials.

#### 2. Questions

- a. Would the funds go towards to advertising only?
  - i. Yes. This would include artist passes, food passes, etc.
- b. How much have you spent on advertising in the past?
  - We have spent on \$500 food passes, and about \$1,000 on advertising.
- c. Do you combine with EU's budget?
  - We pay for the stage, headliners, etc. EU provides the giveaways and rides.
- d. If you are unable to be allocated the \$1,000 what is the minimum you would like?
  - i. \$500 to go towards posters and food passes.

    - i. Speakers For
      - Speaker 1: They did get less then what they asked for but they scaled back their appeal a lot from what they had originally wanted. They would appreciate the extra \$250. It is a tradition and giving them this money would help in entertaining students.
      - Speaker 2: Chairperson Casey has worked with the organizations in advanced so they came to this meeting with exactly what they needed.
         Just because they said that \$500 is the minimum they would want doesn't mean that's all they should get.
    - ii. Speakers Against
      - Speaker 1: They said they just wanted it for advertising and we all already know about the event. Adding some posters around campus will not make it more known to us. Advertising won't directly help the students. When asked how much they would want they said \$500.
      - Speaker 2: They have already taken ¼ of the budget. They already work with Entertainment Unlimited and should work with them to come up with more money. If we give \$500 to both organizations we get the same done. We only have a little money to give out this evening.

#### ii. Newman Club

 Appeal: Apparel gives the Newman club identity outside of meetings and events and spreads the name of Newman club around campus. We also need money to go towards the van rental and the fuel cost to go to Kentucky. This gives our organization an alternative Spring Break option that gives them a different perspective of the world. It is imperative that we get this funding because we do not have a safe way of getting there on our own.

#### 2. Questions:

- a. How much are you requesting?
  - 1,008.03 per van, 345.00 for gas mileage, \$250 for tshirts
- b. If you were to choose between the van rental and mileage which one is a priority?
  - i. Van Rental
- c. Do club members have to pay for the retreat?
  - We try to fundraise as an organization but students do have to fund out of pocket.
- d. How much do you pay out of pocket?
  - i. About \$400-\$600.
- e. What is the priority between t-shirts and the mission trip?
  - i. We are under the impression that every organization is guaranteed the \$250 for apparel.
- 3. Motion to add \$1008.03 for one van
  - a. Motion Seconded
  - b. Motion Objected
  - c. Debate
    - i. Speakers For
      - Speaker 1: their t-shirts are not a priority and they can fundraise on their own. It is extremely important that they have the transportation to get to Kentucky to go on their retreat. They can cover the gas price much easier per person. There are still weekly appropriations meetings they can come to for the gas money.
      - 2. Speaker 2: We are here to help support clubs and help support their purpose. In order to do that they need the vans to get to the trip. It is extremely hard to raise \$2000 and we really need to give them this money. It is already about \$500 a person and it would not be good if people can not go on the retreat because they can not afford it.

#### ii. Speakers Against

- Speaker 1: I understand why we want to give them this money but we do not have that much money to give out this evening. We should give out \$500 and they can fundraise for more and come to appropriations. We might as well give a little lower then what they want. We still have 6 more clubs to give money to this evening. It would be cheaper for them to bring personal cars.
- Speaker 2: If we cut out \$1000 now other clubs might not get what they need. They can get the remaining money at the end of the night that does not get allocated to the other clubs.

      - Speaker 1: The previous objections to wanting to allocate \$800 were in regards to having no backing. We should allocate ½ of the van money and then the full price of gas. Paying \$400-600 out of pocket is extremely expensive.
      - Speaker 2: They have been able to fundraise
        the money themselves in the past and so if we
        fundraise ½ of the van they would be able to get
        the rest themselves. Funding the gas money is
        good because it is the max the policy will allow
        and so they are already having to cover the
        remaining money out of pocket.

# ii. Speakers Against

 Speaker 1: It is important that they get to the retreat so we should allocate 75% of the van cost. They can fundraise the money for bake sales and there are weekly budget appropriations meetings they can go to.

- Speaker 2: they said the gas money is their least prioritized item. With this proposition they are going to loose money on the van. The 75% we deemed necessary for the van would make them better off.

#### iii. Entertainment Unlimited

- Appeal: they are requesting money to fund more of Music Fest. During Music Fest, EU generally spends \$25,000 on rides, port-a-potties, garbage pales, and workers before and after the event, etc. We intend on using \$8,000 from our on campus funds and are requesting \$1,000 tonight from SGA. We would still need \$17,000 to fund the event.
- 2. Questions:
  - a. Do you work with Hofstra Concerts?
    - i. Yes, we are willing to cut back advertising costs to fund more of what we need to contribute.
  - b. What is the minimum amount you would request if not allocated fully?
    - We would like to be allocated at least \$500 to have more money for other campus events.
  - c. What are some on campus events that you put on?
    - i. Casino night, thanksgiving dinner, midweek madness.
  - d. If you move some budget money to Music fest from your on campus account will these events still be feasible?
    - To an extent, the organization already has a deal in place to get two comedians for the price of one.

    - i. Speakers For:
      - Speaker 1: giving them \$1000 is best fit for EU's purpose. They need the money to function. We need a fence to go around the event and it will not happen if they do not get the money.
      - Speaker 2: Their purpose is to put on events.
         They put on a lot of events but that is the clubs purpose. We want to make sure that the club gets the funds they need to put their events on. This event is for the entire student body, not just their organization.
    - ii. Speakers Against
      - Speaker 1: If we don't give them \$1,000 music fest will still happen. They want the additional money for other events that they can fundraise for. They put movies on every weekend that could be reallocated.
      - 2. We only have \$3,498.00 for four more clubs that are coming this evening and we do not know what they are asking for. They can put on other events if we don't allocate them the full amount. There will be other appropriations meetings they can come to get the extra money. We should allocate them 80% and they can come back at a later date for more funding.

  - Speaker 1: we have seen the clubs that are asking for the largest amount of money in the beginning so no club coming in will be

- b. Speaker 2: \$1,000 is being advocated by the appropriations committee. There is clear thought being put into this allocation because we cannot put on music fest without it. We are not going to have the amount required during appropriations meetings to give them this money in the future.

      - Speaker 1: this event would benefit the Hofstra Community. Safe Sex education could benefit our students and give us a good background in the subject. This is a culture on all college campuses and needs to be addressed,
      - Speaker 2: We do not have the statistics to say this event will not be successful. Raising every single dollar is difficult. This cause is important and we have the funds here to give them.
    - ii. Speakers Against:
      - Speaker 1: \$150 is a feasible number to obtain by fundraising. We need to fund the other organizations coming this evening first. The only people who go to their other events are already in the organization, not the student body.

In terms of the socials, they would help the club grow and grow on both the social and professional level. You learn a lot of technique different moves by

interacting with them. Our organization wants to have more fun so going to this social event will benefit our club members.

#### THE CONSTITUTION OF THE ANTHROPOLOGY CLUB

#### PREAMBLE:

Under Article 1, Section 2, of the Student Government Association (SGA) Constitution, the following organization is hereby granted approval to function as a student organization for the best interest of the University community. It is the duty of this student organization to follow the Student Government Association's Constitution and Policy Series. Membership in this organization is open to all full-time undergraduate students without regard to race, color, religion, sex, sexual orientation, age, national or ethnic origin, physical or mental disability, marital or veteran status ("protected status") in the conduct and operation of its educational programs and activities, including admission and employment.

#### ARTICLE I. NAME

Section 1. The name of this organization shall be the Anthropology Club.

#### ARTICLE II. PURPOSE

Section 1. The purpose of the organization shall be:

- A. To learn about the various fields of anthropology and how they all relate to each other.
- B. To learn about current anthropological studies, field schools, papers, articles, etc.
- C. To organize trips to museums, talks, and conferences surrounding the various topics of anthropology.
- D. To network with other students and professors in our fields or related fields of study.

# ARTICLE III. CLUB ADVISOR

Section 1.

- A. The Club Advisor for this organization must be a non-student Hofstra University employee.
- B. The advisor must be approved by a two-thirds vote of the active members of the organization.
- C. The duties of the Club Advisor will be the following:
  - a. Mentor and advise the organization on how best to fulfill its purpose.
  - b. Hold members and officers of the organization accountable.
  - c. Provide structure for the meetings of this organization and serve as a resource for all members and officers during meetings.

#### ARTICLE IV. MEMBERSHIP

Section 1. Any full-time undergraduate student at Hofstra University may become a member.

#### Section 2. Status of Members

- A. Members shall be recognized as active after attending one meeting.
- B. An inactive member shall be a member who misses more than seven meeting in any given semester.
- C. An inactive member may be reinstated to active membership by a two-thirds vote of the active members present and voting at the meeting.
- Section 3. Only active members shall be allowed to vote at regular meetings.

## ARTICLE V. DUTIES OF OFFICERS AND THEIR ELECTIONS

- Section 1. It shall be the duty of the President to:
  - A. Preside at full meetings of the club.
  - B. Act as a member ex-officio of all club committees.
  - C. Represent the club where such representation is required, requested, or deemed appropriate and/or acceptable.
  - D. Carry out or delegate all duties not specifically vested in any other officer of the club.
  - E. Work with other clubs/departments to organize events for the school.
- Section 2. It shall be the duty of the Vice President to:

- A. Assume the duty of the President in the event of a resignation or removal of the President or in the event that the President cannot for any reason fulfill his/her duties.
- B. In the event that a chairperson of any committee is unable to fulfill his/her duties, act as temporary chairperson of any committee until a new one is appointed.

## Section 3. It shall be the duty of the Secretary to:

- A. Keep complete minutes of all the club meetings.
- B. Preserve carefully all the records and materials accumulated in the connection with his or her work and transfer them into his or her successor.
- C. Be in charge of all correspondence.

#### Section 4. It shall be the duty of the Treasurer to:

- A. Meet with the Internal Review and Control Board representative when deemed so necessary.
- B. Be in charge of all clothing orders.
- C. Keep track of all records concerning all club funds.
- D. Attend any Appropriations Committee meetings when necessary.

## Section 5. It shall be the duty of the Publicity Chair to:

- A. Promote the club in all its activities by making and distributing flyers, running the table in the student center when necessary, etc.
- B. Run all of our social media (Facebook, Twitter, etc.).
- C. Keep the Get Involved HU page up to date.

# Section 6. Election Procedure

- A. Elections shall be held at the last meeting of an academic year for the ensuing academic year.
- B. The presiding officer shall take nominations from the floor. Any active member may nominate any other active member for any office.
- C. There shall be a secret ballot and election shall be constituted by a simple plurality of active members present and voting.
- D. All ballots must be cast in person. No voting by proxy will be permitted at any election.

- E. The order of voting shall be from the most important position to the least important (i.e. President, Vice President, Secretary, Treasurer, and Publicity Chair).
- F. Elected officials shall take office at the first meeting of the semester immediately.
- G. Procedure in the event of resignation, removal, or vacancy:
  - a. Any vacancy in the presidency shall result in the succession of the Vice President to the presidency.
  - b. If for any reason the Vice President cannot assume the presidency, an election shall take place as soon as possible to elect a new President.
  - c. Any vacancies in any other office shall be temporarily filled by an appointment by the President until a proper election can be held.

# ARTICLE VI. MEETINGS

Section 1. Meetings shall be held either every week or every other week. The exact amount of times and dates will be determined every semester by a common agreement of the active members.

# ARTICLE VII. REMOVAL OF MEMBERS/OFFICERS

#### Section 1

- A. If it is determined that a member/officer is not fulfilling the duties of his/her position, or is violated the rules and procedures of the club, he/she shall be removed in the following manner:
  - a. Given a warning of what he/she has done wrong and the consequence of his/her actions.
  - b. Removal from the active roster.
- B. After all procedures have been carried out, a two-thirds vote of active members is required to the member/officer.

## ARTICLE VIII. METHOD OF AMENDMENT

Section 1. Proposed amendments to this constitution shall be presented at any regular meeting and shall be ratified by a two-thirds vote of the active members present and voting at the following regular meeting.

Section 2. All amendments must be approved by the Rules Committee of the Student Government Association.
