### What We've Done:

- Changed the office hour requirement for club office spaces from 8 hours a week to 2 hours a week and we have been recording them with hour recording sheets on each club door (thanks Wiley!).
- Held open storage time in the SGA storage space in IEI over 2 days (4 hours total) for clubs to come and label/claim anything that belongs to their club. Before the end of the semester we will be cleaning the space and making as much room as we can so that we can order storage bins next semester for clubs to more efficiently store their club belongings!
- Put together an SGA information packet for club leaders with everything they need to know to make SGA-recognition the most beneficial it can be for clubs! This packet will go out to club leaders next semester at the club leader training that is being planned.
- Started a conversation about issues we saw within SGA and areas in which we believed we could improve. This led to a couple of proposals for a new structure that we brought to the senate, before finally landing on one that we felt would accomplish the goals we had for SGA. Finally, we wrote a brand new constitution to the senate that made major structural changes that push SGA towards direct advocacy and representation for students, and... IT PASSED!
- Next semester the Club Relations Committee and the Rules Committee will be combined to form the new Club Resource Committee which will more effectively assist SGA recognized clubs, with that being said this was the absolute best Club Relations Committee that has ever existed, we lived fast and died young everyone!!

- The Public Relations Committee worked with the Rules Committee for organizing orientation events over the summer.
- The first task of the fall included the Club Fair to get students engaged in running for SGA
  positions.
- We attended each of the monthly Hofstra Fall Open Houses where we met potential high school students and promoted the work we do as an organization.
- We managed the Instagram, Facebook and Twitter accounts promoting the flyers of SGA
  events and of different offices on campus. Instagram stories are used daily for promotion
  of SGA and the departments we work with.
  - For each week of programming put on by the Spirit Committee and the Student Services committee we made posts for the individual days along with the weekly calendar. We also created a video for Student Appreciation Week which highlighted the events of the week and the importance of taking the SGA survey.
- The platform Canva is how the Public Relations Committee designed flyers for all of SGA's events along with specific requests from the committees. We follow Hofstra's Branding Guide when making posts to ensure a cohesive look with school colors and

- aesthetic. We post these events with first lifestyle pictures of our members followed by the detailed flyers.
- The Hofstra Portal Box has been utilized to promote the events of SGA and the guests at our meetings with the goal of having students interested in attending Senate meetings.
- On October 23rd we participated in #dayinthepride with videos on our instagram stories and posts through our other social media accounts.
- SGA has been highlighted in The Hofstra Chronicle in a few different weekly editions.
   There were recap articles written after our basketball game tailgate and after our SGA
   Open Forum, as well as a feature of Cabinet in Fall 2019.
- SGA has also been featured by journalism students for certain class products and has been a topic of interest for gathering information from and about.
- We created postcards for the Student Services Committee for addressing student needs
  directly. We want to have these postcards submitted through a physical mailbox in the
  SGA office for students to come and meet the members of SGA while submitting their
  suggestions for us.
- Since we are restructuring this semester, January will be a time of introducing the new

### Fall 2019 Elections

The Rules Committee facilitated the Fall Elections of the 84th Senate. Over thirty (30) students attended Election Information Sessions to learn more about the election process. By the end of the election process, the Student Government Association had the pleasure of welcoming twelve (12) new senators and three (3) new justices into the organization.

Following the culmination of elections, many students were sent the application to become associate members of SGA. Associates have been welcomed into the committees and have been working hard alongside the senators to implement programming and complete required committee duties.

### Club Elections

For the Fall Semester of 2019, fifty-two (52) club elections have been facilitated by senators this semester.

In May of this year, a new form was made utilizing Google Forms to submit newly elected e-board members' information to the Rules Chair. The next step is sharing the system with advisors to ensure they have the most updated information to contact the clubs they oversee.

### Policy Updates

The Student Government Association has passed 10 pieces of legislation up to this point.

Last week a Constitutional Convention was enacted to allow the Student Government Association (SGA) to restructure our committee set up and how the organization is run. Various proposals have been brought up to senators and the current proposal is now into the drafting process to redesign SGA and make it a better advocating body with Club Relations Committee Chairman Joseph Alameda spearheading the efforts.

Various edits have been made to the Policy Series up to this point to encourage senators to run more club elections and to move the Service Chair from the Spirit Committee to the Student Services Committee. A few more edits have been passed to make policies fairer for clubs with office spaces.

Also when you ran you had to choose what committee you sit on and you should see the time it takes because you signed up for it.
