VI. New Business

- A. SGA Recognition Presentation of Pi Kappa Delta
 - i. Pi Kappa Delta is a national Forensics honor society. It is intended to give people who can't speak for themselves a voice. They also serve to teach people who do not know how to speak for themselves a way to do that and inform them the best way to represent themselves. They want to foster good relationships between people with similar ideals. The society also serves as a networking opportunity through alumni and people from other universities. It is a place where ideas can be fostered. Whenever a problem arises, they have an open caucus about it and listen to others' perspectives of issues regardless of your standpoint on it.
 - 1. Questions
 - a. How many members do you have?
 - i. 25 people initiated into the chapter, not including eboard
 - b. How many people are on your eboard?
 - i. 5
 - c. What does SGA recognition mean to you?
 - i. They want to spread their chapters mission around campus
 - d. How do you help people with their speaking?
 - i. You listen to them. You hear their ideas and what they have to say on each issue.
 - e. Are these tournaments national? Would you need SGA funding?
 - They are regional, and they do not need funding for it. They would need funding for recruitment of new members
 - f. What is the makeup of your membership?
 - i. Relatively equal distribution between classes.
 - g. How will you promote recruitment?
 - i. Bring together Hofstra Republicans and Hofstra democrats to see that you can have multiple perspectives on the same issue.
 - 2. Motion has been made to extend questioning period for 1 minute

- a. What is your application process?
 - i. The application consists of 1 25 dollar fee
- b. Are their tournaments every month?
 - i. Currently yes one is scheduled for each month
- 3. Motion has been made to extend questioning time by 2 minutes
 - a. Can you deny membership?
 - i. What is in the constitution
 - b. Is their any form of exclusivity?
 - No we encourage everyone to be apart of the organization.
 - c. What happens when people do not make the three tournaments?
 - i. The organization understands that people have their own schedules, but you do not need to attend three consecutive tournaments just 3 by the end of the year.
 - d. How do you fund tournaments?
 - i. The department pays for them.
- 4. Move into debate to pass Pi Kappa Delta Honor Society
 - a. Senators For:
 - i. Speaker 1: The team is currently exclusive so the department can't fund for everyone. They are looking to SGA because they don't want to prevent people on the team from going on the debate trips.
 - ii. Speaker 2: successful clubs look good on the senate and the university as a whole. This club will be headed by great leaders. The club is made up of diverse class levels and will grow overtime. They have the open conference idea with Hofstra republicans and Hofstra democrats. The club is not exclusive.
 - 1. Point of information made by senator Esteban: If membership is not exclusive why do you need to attend three conferences and have a minimum GPA?
 - a. Point of clarification: membership is official after 3 tournaments, similar to how you can sit on a committee in SGA, and you need

to attend three meetings in order to be considered.

- 2. Point of information: Does every club require full time undergraduate student status?
 - a. Yes.
- 3. Point of information: Why can membership become inactive after missing 3 meetings?
 - Point of clarification: If you are inactive the department cannot fund for people who do not attend meetings regularly over people who regularly attend meetings.
- b. Senators Against:
 - i. Speaker 1: He is weary on membership. Senator Stengel yields his time to chairperson Shepherd.
 - ii. Speaker 2: it sounds exclusive regardless of what they said earlier. Although it is a national constitution, they should change it so the Hofstra Chapter does not seem exclusive.
 - iii. Speaker 3: speaking to exclusivity, there is a 2/3-vote process that is written in the constitution that could potentially limit membership of someone who does not receive the 2/3 votes.
- c. Motion to extend debate by two minutes, one minute speaking time for each speaker.
 - i. Motion has been seconded
 - ii. Motion has been passed
- d. Speaker for:
 - i. Speaker 1: the time commitment is what you make it. The point of a 2/3 vote is a national policy that Hofstra does not follow. The president of this chapter is the president of the national chapter as well and would look really awesome for Hofstra.
- e. Speaker against:
 - i. Speaker 1: since it is written in the constitution it is still a concern and a possibility of happening. He is not comfortable taking the risk of limiting membership because it is written in their constitution, giving them the ability to do it.
- f. There is discussion to have the club come back next week after working with SGA to fix the wording of their

- constitution, or amend the constitution this evening with a 2/3 vote of senate.
- g. Motion to move to a vote to pass Pi Kappa Delta as an Honor Society.
 - i. With a vote of 18-3-2 Pi Kappa Delta, Forensics Honor Society has passed for SGA recognition.
- B. Pending Club Relations Nominations
 - i. Senator Solis still intends on running for the position

 - 1. Senator Cinquemani accepts nomination
 - iv. Election of Club Relations Chair
 - Senator Solis
 - Senator Solis is only involved with one other club on campus and intends on committing her time to her schoolwork and this committee. She has met with Francine Chirico to hear about what the position entails and what the expectations will be. She believes that it is important for clubs to work together for big events on campus and she intends on helping that. She would like to strengthen the definition of "Club Congress" by having the clubs speak on what their strengths, weaknesses, and issues are so they leave club congress happy and satisfied. She would like to categorize the clubs at Hofstra and have a committee member designated to those clubs so solutions can be made easier and more effectively. She has been vice president of the debate team in her high school and is familiar with working with other students and helping them succeed. If elected, she would be ready to take on the workload and the expectations of the position.
 - b. Questions
 - i. Why do you want to be the club relation's chair?
 - My determination and my drive to help others succeed at Hofstra are truly important.
 - ii. What are your biggest strengths and weaknesses?
 - 1. Her strengths are stated above, and her weaknesses would be her overthinking and over preparation. She puts a lot of pressure on herself to get things done a certain way.
 - iii. Do you think being a first year student would make this position difficult to handle?

- 1. No, because her course load is not too difficult and intends on staying with the position.
- iv. How would you run your meetings?
 - Categorizing would mainly be for email correspondence. Those emails would be discussed at meetings so everyone is on the same page. She would have each committee member discuss the issues in their email categories and see if solutions can be made collectively.
- v. Do you have fundraising events in mind?
 - 1. No particular events in mind, but she intends on helping clubs come up with fundraising ideas.
- vi. If two clubs were in collaboration, how would the email correspondence work?
 - 1. The committee would work together
- vii. Are you available at 8 P.M. on Wednesday nights?
 - 1. Yes

2. Senator Bekios

a. Senator Bekios' first experience with SGA was through being involved with another club on campus. She would like to jump into contacting clubs for cosponsoring events. Clubs of the same category should be invited to open forum meetings to get new ideas and get to know each other. They will also be able to support each other. She believes that club congress should be held at the beginning of each semester in order to hear specific concerns, and work with rules to see these changes. She believes that her new perspective will help the view of this committee. She has leadership positions on and off campus and has experience planning and organizing events for large groups of people.

b. Questions

- i. How would you help clubs fundraise?
 - 1. She wants to help clubs find ways other then bake sales to raise money. The committee should directly guide clubs on this issue. If swipes were taken at bake sales then they might be more effective.
- ii. How would you best manage your time?
 - 1. None of her other organizations get in the way of committee meetings and her current

obligations. She is flexible and wiling to meet with people outside of meetings.

- iii. How would you run a committee meeting?
 - 1. First talk about new business, then get a certain number of clubs discussed from each category so what they are doing impacts enough clubs.
- iv. What are your strengths and weaknesses?
 - 1. Her weakness is that she places a lot on herself to get things done by a certain time but that can be an asset. Her strength would be her willingness to learn and that she is not afraid to ask for help when needed.
- v. How would you face adversity in collaborating with clubs?
 - 1. She would ensure that the clubs sit down together and figure out what they would like to do in those meetings rather then emailing back and fourth.
- vi. Are you available at 8 P.M. on Wednesdays?
 - 1. Yes.

3. Senator Cinquemani

Senator Cinquemani wants to make this school a better place, and a huge part of doing that is through club involvement. Students join clubs based on their values. She has access to many groups of people based on the other organizations that she is involved in. Her intended major is business management, so running an event with Club Congress and working with appropriations will help her planning skills. She is really good at sending quick emails back to club leaders. She intends on having open office hours to help clubs navigate things on campus. She wants to work with appropriations to create a fundraising packet to channel all fundraising ideas into one. She would also like to have a packet with the information on how to start a club so it is clearer then the online forms. She would like to collaborate with other clubs to raise more awareness for the things that are mutually important. She would like to have a list of what missions and purposes are similar to better help clubs collaborate. She would like to meet with clubs on a weekly basis just to check in and see how they are doing.

 - a. Senator Solis
 - i. Speaker 1: She sat with the previous chair and that shows that she will be committed to this position. She is readily available and that is what this position needed. She is leadership capable and has experience in leadership positions. She wants to help others succeed as well as herself and this would be a great way for her to grow.
