 - A. Club is unlike any other on campus
 - B. Don't have to be a science major, anyone can come
 - C. Take advantage of clubs on campus
 - D. Looking to order T-shirts, go to different museums

 - 1. Comptroller M. Hershfield- who's your advisor
 - 2. Senator B. McElroy- members? 8
 - 3. Senator P. Tran- what events will you have? Observation schedule and meetings
 - 4. Spirit Chair L. Daves- funding? –T-shirts to promote our club, to go to different events- like listen to NASA astronauts at Cradle of Aviation, this one is free but others charge for admission
 - F. Senator B. Schafer motions to skip debate go to vote, no objections
 - G. Club passes, with 5 abstentions
- IV. Comptroller M. Hershfield motions to suspend rules to see speaker Leonard Jones of Residential Programs
 - A. L. Jones- spoke last semester about co-ed housing, just wanted to give everyone and update and talk a little bit about room selection.
 - B. Co-ed housing- the opportunity for two different genders to share a suite, will be taking place in the 2012-2013 school year, on the first floor of Norwich House in Colonial Square
 - 1. Why this option? If friends wish to live together, regardless of gender, that will support each other and have the same values.
 - 2. Will be working on FAQs to hand out shortly.
 - 3. Sophomore, juniors and seniors can sign up for this option; the application must be filled out in person by March 19th. Please fill the entire suite
 - 4. Spirit Chair L. Daves- will the RA be living with the co-eds in the suite?
 - a. Yes, both the RA and the residents will be aware of this. We want them to chose this option.
 - 5. Programming Chair C. Rauchle- doesn't the RA have to sign off on this agreement as well.
 - a. The suite will be filled before we place the RA, as of now.
 - 6. Programming Chair C. Rauchle- why only the first floor?
 - a. Right now Colonial Square is only about 75% full, and Norwich house has emptied out, according to stats. We didn't want to

have to displace students (homesteaders). If there is enough demand, we will open it to the second floor.
