I understand that if I do not pay the full amount due under this dining dollars contract, or any other amount due on my student account, I will be responsible for all costs and expenses associated with the collection of such unpaid amounts, including the fees of any collections agency, which may be based on a percentage of the total balance due (up to a maximum of 45%) and reasonable attorney's fees.

Please be advised that payment must be made at the Student Financial Services office. Students will receive a full refund of unused points if cancellation notification is received before Friday, May 5, 2023, for Session I; Friday, May 26, 2023, for Session II; and Friday, July 7, 2023, for Session III.
