1. Introduction of the Committee members and the roles of GAAC.

a. Faculty Policy Series 11 and 11G

Committee members reached a consensus to continue collaborative work on unifying Faculty Policy Series 11 and 11G. A shared document will be distributed to committee members for further collaboration.

b. Probation Notification Timeline

Registrar Evan Koegl proposed language changes, which were unanimously approved by all committee members. The revised language reads as follows:

"All students placed on academic probation will be sent a letter by the Office of Academic Records informing them of their probationary status by the end third week of January following the fall semester and by the end-third week of June following the spring semester."

c. New grading scheme for Doctor of Nursing Practice programs

Concerns were raised regarding the alignment of the new grading scheme with broader university system standards. Further clarifications are required. Patricia Sarcona will follow up with Renee McLeod-Sordjan to explore possible modifications to the proposal. The discussion will continue in the next meeting.

d. Dissertations and defenses

Committee members expressed interest in understanding the rationale and objectives behind investigating dissertation and defense procedures at Hofstra and peer institutions. A discussion regarding the potential proposal of a general university policy for dissertations and defenses will continue in the next meeting. Comila Shahani-Denning will provide additional background information on this item.

- c. **Dissertations and Defenses**: In response to R2, Comila Shahani-Denning suggested conducting research on best practices for Dissertations and Defenses at peer universities. GAAC may propose a university-level policy for Dissertations and Defenses. Stephen Hernandez volunteered to conduct research and share the information with the committee at the next meeting.
- d. **GA/TA Studentships**: Brian Galli raised concerns about limited GA/TA opportunities for graduate students. He and Umera Fatima Riyaz will form a subcommittee to research this topic.
- e. Communication to International Graduate Students: Zunayeed N Alam expressed concerns regarding the English Placement Test requirement. Many international graduate students were under the assumption that they had received a waiver for English tests during admission but were later asked to take the English language placement test when they joined the program. Comila Shahani-Denning suggested seeking clarifications from the Graduate Admission Office and INTO. Monica Florio may provide some information in the next meeting.
- f. **AI Policy for Graduate Students**: The University AI Task Force has drafted recommendations to the Provost Office regarding AI use (<u>link</u>). The Provost Office has recommended language about AI use on syllabi (<u>link</u>). Considering that these are all recommendations, the GAAC committee discussed whether to develop an AI use policy for graduate students. Carolyn McCummings will research AI policies at other institutions, and the discussion will continue in the next meeting.
