To be qualified for severe economic hardship work authorization you must show proof that your financial difficulties were caused by unforeseen circumstances beyond your control. These circumstances may include loss of financial support without fault on the part of the student, substantial fluctuations in the value of currency or exchange rate, inordinate increases in living costs, unexpected changes in the financial condition of your source of support, medical bills, crisis in the home country, or other unexpected major expenses.

If you believe you are eligible, please gather the required documents and email to international@hofstra.edu for review. Requests will not be considered without this budget form, supporting evidence, and your explanation letter. Only after we determine your eligibility, will we give you instructions on how to pursue the application with USCIS.
