Without any compensation or notification to or approval by Guest Lecturer, the Pictures or Recordings may be used, reproduced, or otherwise published by or on behalf of Hofstra University directly or indirectly for any purpose, including but not limited to advertising and/or promotional purposes, in any manner, and at any time that Hofstra University desires.
